

Privacy Policy

We have adopted the Australian Privacy Principles (APPs) contained in the Privacy Act 1988 (Cth) (the Privacy Act). The NPPs govern the way in which we collect, use, disclose, store, secure and dispose of your Personal Information.

What is Personal Information and why do we collect it?

Personal Information is information that identifies an individual. We collect your personal information via our credit applications, hire schedules, online equipment and transport bookings, identity checks and verbal conversations with you both on the phone and in person.

We collect your Personal Information only for the purposes of providing top quality services to you and to assist us with our accounting and administration. This assists us to protect you and ourselves from fraudulent activity.

Sensitive Information

Sensitive information is defined in the Privacy Act to include information or opinion about such things as an individual's racial or ethnic origin, political opinions, membership of a political association, religious or philosophical beliefs, membership of a trade union or other professional body, criminal record or health information.

PLEASE NOTE: We do not seek or collect any sensitive information as outlined above as it has no bearing on our ability to provide hire services to our customers.

Third Parties

Where reasonable and practicable to do so, we will collect your Personal Information only from you. However, in some circumstances we may be provided with information by third parties. In such a case we will take reasonable steps to ensure that you are made aware of the information provided to us by the third party.
